(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

All that lot of land in City of Greenville, Greenville Township, Greenville County, South Carolina, on Clayton Street, known and designated as lots Nos. 69 and 70 as shown on plat of the Perry Estate recorded in plat book F, page 127, and having the following metes and bounds: Beginning at an iron stake on the south side of Clayton Street, joint corner of lots 69 and 68, and running thence with Clayton Street N. 58-30 E. 100 feet to iron stake, corner of lot No. 71; thence with back line of lots Nos. 71, 72, and 73, S. 31-30 E. 205 feet to an iron stake; thence S. 61-23 W. 89.86 feet to an iron stake on Laurel Street; thence N. 55-54 W. 22 feet 5 inches to an iron stake on Laurel Street; thence with line of lot No. 68, N. 31-30 W. 179 feet 9 inches to the beginning corner on Clayton Street.
