All that certain tract, or parcel of land, situate lying and being in the State and County aforesaid in Glassy Mt. Township, Beginning on a stake on C. S. West and B. C. Adkins line in old Road, and runs thence S. $82\frac{3}{4}$ E. 1.84 to a stake; thence N. $30\frac{1}{2}$ E. 26.38 to a stone on D. R. Evins line; thence N. $24\frac{3}{4}$ W. 22-37 to a stake on Greens creek thence up creek about seven chs. to the mouth of a small branch; thence up small branch, about 11ch. to a stone; thence S. $83\frac{1}{2}$ W. 85 links to a stone on road; thence with road S. 1.5 E. 6.08 to turn in said road; thence with road S. $18\frac{1}{4}$ E. 6.30 to turn in said road; thence with road S. $10\frac{1}{2}$ E. 3.72 to turn in said road; thence with road S. $51\frac{1}{2}$ E. 2.77 to turn in said road; thence with road S. $10\frac{1}{4}$ E. 3.70 to turn in said road; thence with road S. 12 W. 1.30 to turn in said road; thence with road S. $27\frac{1}{2}$ E. 1 ch. to turn in said road; thence with road S. $1\frac{1}{4}$ W. 2.24 to stone on west side of Road., thence up old road S. 7.40 W. 4 chs. to the beginning corner, and contains $49\frac{3}{10}$ acres, (forty nine and three tenths acres, more or less, bounded by lands of D.
