

All that certain tract, parcel or lot of land, situate, lying and being in Greenville County, South Carolina, described as follows:

Lot in Oak Mill Village on Pinckney Street, and being designated as Lot no 19 of the Hammett lands as shown by plat in Deed Book 2442, page 835, and having the following course and distances. Beginning on Pinckney Street at the corner of Lot No 18 and running thence with said street in an easterly direction 100 feet to corner of Lot no 20, thence with line of Lot no 20, southerly 140 feet to a ten-foot alley; thence with said alley in a westerly direction 100 feet to line of Lot no 18; thence with line of said lot in a northerly direction 140 feet to the beginning corner and being the same conveyed to Ometa Thompson by E. Lot no 9 in Block P of a subdivision known as Park Place, as recorded in Plat Book A, page 119, having a frontage of 50 feet on Reid Avenue, and 89.8 feet on the south side of Fourth Street and 77.6 feet on southeast side of Owens Street, running along the line of Lot no 8 to an alley, the said two lots being a portion of the property conveyed to Ometa Thompson by E. Inman, Master by deed dated January 20, 1931 and recorded in the R.M.C. Office for Greenville County.
