All that certain piece, parcel or lot of land situate, lying and being in Greenville County, Greenville Township, State of South Carolina, adjoining Lot no. 6, and being designated and known as Lot no. 5 of Block "A" of the property of Mountain View Land Company, as shown on a plat recorded in the Office of R. M. G. for Greenville County in Plat Book "A", Pages 396 and 397, and having the following metes and bounds, to wit:

Beginning at a pin on the west side of Buncombe Road, joint corner of Lots nos. 5 and 6, and running thence with line of Lot no. 6, 189 feet to a pin on a ten foot alley; thence with said alley in a southeasterly direction 50 feet to a pin, joint corner with Lot no. 4; thence with line of Lot no. 4 in an easterly direction 190 feet to a pin on Buncombe Road, thence with said Buncombe Road N. 22 W. 50 feet to the beginning corner.
