Eyes, Fields Masters and Barney Holcombe as trustees for the Church of God near Slater Mill the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said E. I. Eyes, Fields Masters and Barney Holcombe, as Trustees for the Church of God near Slater Mill and their successors in office S. W. Latimer General overseer, Head quarters at Cleveland Tennessee.

All that piece of land lying situate and being in Saluda Township, State and County aforesaid. Known as a part of the land conveyed to me by deed from E. Inman, Master adjoining land of myself + Mrs. Sallie Bridges. Beginning on i. p. S. E. corner thence running N. 57 W. 2.00 chs to a Red oak thence N. 26 E. 2.07 to i. p. thence S. 45 E. 2.16 to i. p. thence S. 27 W. 1.63 to the Beginning corner and contains 1/2 acre more or less.

The above described land is not to be sold and if they fail to use the Church for religious purposes said land to revert back to E. I. Cox and his heirs or assigns.

The above described land is a part of the same conveyed to me by E. Inman Master on the 11 day of January 1935, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 2, Page 577.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said E. I. Eyes, Fields Masters + Barney Holcombe trustees + their successors in office as long as the Church is used for religious purposes do hereby bind myself + my heirs, executors and administrators warrant and forever defend all and singular the said premises unto the said E. I. Eyes, Fields Masters + Barney Holcombe + their successors in office heirs and assigns, against me and my heirs and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
