"All that certain piece, parcel or lot of land lying and being situate about one-half ($\frac{1}{2}$) mile north of the village of Travelers Rest on the West side of the Tubbs Mountain Road and being known and designated as Lot No. 51 on a plat of the Love Estates, which said plat was made by W. J. Riddle, Surveyor, in April 1938 and is recorded in the RMC Office for Greenville County, S. C. in plat book I at pages 111 and 112 and being a portion of the property conveyed to W. 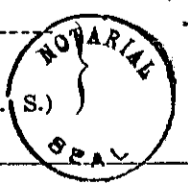
