(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
W. C. Johns and Hattie E. Johns:

All that certain piece, parcel or lot of land, situate lying and being in the State and County aforesaid, in Chick Springs Township, about 5 miles North of the City of Greenville and having the following metes and bounds to-wit:

Beginning at an iron pin in the center of the road leading to East side of Paris Mountain, 113 feet from the center of Buckhorn Road and running thence S. 28-42 W. 598.8 feet along lands of W. C. Adams to an iron pin, joint corners with lands of W. C. Adams and W. T. Henderson; thence along lines of the W. T. Henderson land, N. 81-30 W. 413.5 feet to an iron pipe; thence continuing with line of W. T. Henderson, N. 88-15 W. 206.8 feet to an iron pipe joint corners with the W. C. Adams lands; thence N. 38-50 E. 892.9 feet to an iron pin in center of the road leading to East side of Paris Mountain; thence with said road; S. 55-16 E. 417 feet to the iron pin in center of road, the beginning point and containing 8.07 acres, more or less, according to a plat made by Dalton and Neves, November, 1938.
