the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said F. P. Poole and his heirs and assigns:

All our right, title and interest in and to all that certain piece, parcel or tract of land situate, lying and being in Greenville County, State of South Carolina, containing 90 acres, more or less, and having the following courses and distances, to-wit:

Beginning at a stake 3x on township line and in the old Buncombe Road and running thence due South with township line 40 chs. to a stake; thence due East 22 chs. to a stake near a forked gum; thence due North 35.25 chs. to a stake in old Buncombe Road; thence up said Buncombe Road to the beginning corner.

Also, all that other tract of land adjoining that above described, having the following courses and distances, to-wit: Beginning at a pine knot and running thence N. 89 W. 22.15 chs. to a P. O. stump; thence S. 4 W. 22.80 chs. to a stone; thence S. 89 1/2 E. 23.15 chs. to a stone; thence N. 89 1/2 E. 22.80 chs. to the beginning corner, and containing 51 1/2 acres, more or less.
