described as follows: Approximately 32 acres, bounded on the

East by the land of Victoria Burdette & W. H. Hart.
South by the land of Baldwin & Snow

Also the right, privilege and authority to cut or trim trees along said line necessary to keep the wires thereof clear at least Ten (10) feet.

PROVIDED, however, any damage (other than tree damage) to the property of the undersigned, caused by the said authority in maintaining or repairing said electric transmission line, shall be borne by said authority, its successors and assigns.
