described as follows: Approximately acres, bounded on the North by the land of Geo. B. Yeargin East by the land of T. M. Vaughan South by the land of Rich Morton West by the land of Mrs. Daisy Wilson

Also the right, privilege and authority to cut or trim trees along said line necessary to keep the wires thereof clear at least Ten (10) feet.

PROVIDED, however, any damage (other than tree damage) to the property of the undersigned, caused by the said authority in maintaining or repairing said electric transmission line, shall be borne by said authority, its successors and assigns.
