to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Traxler Real Estate Company

All those certain pieces, parcels or lots of land in Anderson Street Highlands according to a plat thereof made by Dalton & Neves, Engineers, in 1939, recorded in the R. M. C. Office for Greenville County in Plat Book "J", Page 157, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the Eastern side of Anderson Road 150 feet from the Southeastern intersection of Anderson Road with East King Street, and running thence with the Anderson Road S. 43-27 W. 50 feet to a point, joint Northern corner of Lots Nos. 11 and 12; running thence along the dividing line of said lots S. 47-20 E. 161.1 feet to a point in line of Lot No. 63; thence along the dividing line of Lots Nos. 11 and 63 N. 42-40 E. 50 feet to a point joint rear corner of Lots Nos. 11 and 10; thence along dividing line of said lots N. 47-20 W. 160.4 feet to the point of beginning, and being Lot No. 11.

Also beginning at an iron pin Northeastern/intersection of Anderson Road with East Welborn Street, and running thence with the Anderson Road N. 43-27 E. 50 feet to a point, joint Northern corner of Lots Nos. 12 and 13; running thence along the dividing line of said lots S. 47-20 E. 161.8 feet to a point in line of Lot No. 63; thence along the dividing line of Lots Nos. 13 and 63 S. 42-40 W. 50 feet to a point on East Welborn Street; thence with East Welborn Street N. 47-20 W. 162.5 feet to the point of beginning, and being Lot No. 13.

Also beginning at an iron pin on the Southern side of East Welborn Street 259.7 feet from the Southeastern intersection of East Welborn Street with Anderson Road, and running thence with East Welborn Street, S. 47-20 E. 50 feet to a point, joint Eastern corner of Lots Nos. 19 and 20; thence along the dividing line of said lots S. 42-40 W. 150.85 feet to a point; joint rear corner of Lots Nos. 19 and 20; thence along the rear line of Lot No. 19 N. 47-24 W. 50 feet to a point joint Southern corner of Lots Nos. 18 and 19; thence with dividing line of said lots N. 42-40 E. 150.9 feet to the beginning corner, and being Lot No. 19.

Also beginning at an iron pin on the Northern side of East Welborn Street, which point is 300 feet West of the Northwestern intersection of Hodges Street and East Welborn Street, and running thence along East Welborn Street N. 47-20 W. 50 feet to a point joint Southern corner of Lots Nos. 52 and 53; thence along the dividing line of said lots N. 42-40 E. 150 feet to a point joint Northern corner of Lots Nos. 52 and 53; thence along the rear line of Lot No. 52 S. 47-20 E. 50 feet to a point joint Northern corner of Lots Nos. 52 and 51; thence along the dividing line of said lots S. 42-40 W. 150 feet to the beginning point on East Welborn Street; and being Lot No. 52.
