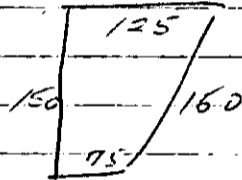

Norwood Cleveland and estate of R. Mays Cleveland made by W. M. Rast in June, 1927 and having the following metes and bounds, to-wit: Beginning at a point on the South side of Midway Drive joint corners of lots Nos. 1, 2 and 81 and running thence North 63-47 West 125 feet to a point joint corner of lots 77 and 78; thence with joint line of lot 77 and 78 150 feet to a point in rear line of said lots; thence South 63-47 East 75 feet to an iron pin joint corners of lots 80, 81, 7 and 8; thence North 44 West 150 feet to the beginning corner.
