E. McKnight I ever had, now have or which I, my heirs, executors, administrators or assigns, or any one of them, hereafter can, shall or may have for or by reason of any cause, matter or thing whatsoever, and particularly any claims or demands arising in and growing out of any services rendered or claimed to have been rendered by me to the said W. E. McKnight for nursing, housekeeping and services of a like nature and kind, either arising by contract or upon quantum meruit.

AND, I, Annie Lee Holloway, further by this instrument and after having been privately and separately examined by Hoke B. Black, a Notary Public for South Carolina, for and in consideration of the above mentioned sum of Four Hundred (\$400.00) Dollars, the receipt whereof is again acknowledged by me, freely voluntarily and without any compulsion, dread or fear of any person or persons whomsoever, renounce, release and forever relinquish any and all claims or alleged claims of dower which I may have in any property of the said W. E. McKnight, and all interest and estate in and to any property of the said W. E. McKnight, which is now held by him, for him, or in his name, wheresoever it may be located, and in any property of whatsoever nature which may be hereafter acquired by him, for him or in his name, and in no instance will I assert any claims to dower or alleged dower as against any property of W. E. McKnight, as set forth in the above manner.
