KNOW ALL MEN BY THESE PRESENTS, That Conyers & Gower, Inc.,

a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Three Hundred and no/100 (\$300.00) DOLLARS.

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Willie H. Fuller, his heirs and assigns:-

All that certain piece, parcel or lot of land situate, lying and being on the West side of Wait Street, just South of the Laurens Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 14 of Block B, on plat of East Highlands Estates made by Dalton & Neves, Engineers, April, 1940, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book K, at pages 35 and 36, and having, according to said plat the following metes and bounds, to-wit:-

Beginning at an iron pin on the West side of Wait Street, joint front corner of Lots 14 and 15 of Block B, and running thence with the line of Lot 15, N. 75-41 W. 140.8 feet to an iron pin on the Northeast side of a 5 foot strip reserved for utilities; thence with the Northeast side of said strip S. 32-23 E. 64.7 feet to an iron pin; thence continuing with the Northeast edge of said strip S. 49-52 E. 104.4 feet to an iron pin on the West side of Wait Street; thence with the West side of Wait Street N. 14-19 E. 90 feet to the beginning corner.

This lot is conveyed subject to the following building restrictions :-

- (1) The lot herein conveyed shall be used for residential purposes only.
- (2) The lot herein conveyed shall never be sold, rented or otherwise disposed of to negroes or persons of African descent.
- (3) No residence shall be erected on said lot costing less than \$1,750.00.
- (4) The building line as shown on the recorded plat and also other restrictions shown on said plat are to be strictly adhered to.
