(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

Doris Hill Williamson, her heirs and assigns forever:-

All that certain piece, parcel or lot of land situate, lying and being on Gibbs Street in the City of Greenville, County of Greenville, State of South Carolina, and having the following metes and bounds, to-wit:-

Beginning at an iron pin on the Southwest side of Gibbs Street, which iron pin is 125 feet east of the Southeast corner of the intersection of Hudson and Gibbs Streets, and running thence with the Southwest side of Gibbs Street, S. 54-21 E. 80 feet to an iron pin; thence S. 35-59 W. 140 feet to an iron pin; thence N. 54-51 W. 80 feet to an iron pin; thence N. 35-59 E. 141 feet to an iron pin, the point of beginning. Being the same lot of land conveyed to me by deed of T. C. Gower, et al, dated April 14, 1939, and recorded in Volume 210 at page 93.

Also, all that piece, parcel or lot of land in Ward three of the City of Greenville, having the following metes and bounds, to-wit:-

Beginning at an iron pin on Hudson Street (Henry Briggs' corner) and running thence with said street S. 27-33 W. 70 feet to an iron pin; thence S. 51 E. 95 feet to an iron pin; thence N. 39-43 E. 66 feet to an iron pin (another of Henry Briggs' corners); thence N. 49-32 W. 109 feet with said Briggs' line to the beginning corner. Being the same lot of land conveyed to me by deed of William A. Briggs dated January 28, 1939 and recorded in Volume 208 at page 297.

Also, all that certain piece, parcel or lot of land situate in Ward 2 of the City of Greenville known and designated as Lot No. I, Block "I" of the Stone Land Co. property and having the following metes and bounds, to-wit:-

Beginning at the intersection of Stone Avenue and the old Chick Springs Road, and running thence along the Eastern side of the Chick Springs Road, N. 61-25 E. 188 feet to an iron pin, corner of Lot No. 2; thence along the joint line of Lots 1 and 2, S. 5-13 E. 149 feet 1-1/2 inches to a point on the extension of Stone Avenue; thence along the northern side of East Stone Avenue, N. 71-50 W. 188 feet to the beginning corner. Being the same lot of land conveyed to me by deed of N. A. McKeithan, Jr., dated January 2, 1937, and recorded in Volume 191, at page 295.

Also, all that piece, parcel and triangular lot of land situate, lying and being in Ward 2 of the City of Greenville, County and State aforesaid, at the intersection of the New Spartanburg Road and Stone Avenue Extension, being more particularly described as follows:-

Beginning at old 3x at the Northeast intersection of Old Chick Springs Road, and East Stone Avenue, at corner of Lot No. 1 Section "I" as shown on Stone Land Co. map made June, 1909, and runs thence with old line of road N. 61-25 E. 128 feet to intersection of that line with that of New-Greenville-Spartanburg Super Highway; thence with the line of said highway in a southwesterly direction following the curve of said highway, to the intersection of said highway, with East Stone Avenue; thence S. 71-50 E. along the North side of East Stone Avenue to the point of beginning.

The purpose of this deed being to convey unto the Grantee hereof the small strip of land lying between Lot No. 1 and the new location of the new Greenville-Spartanburg Super Highway. Being the same lot of land conveyed to me by the City of Greenville, dated February 7th, 1938, and recorded in Volume 194, at page 137.
