All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.
on the South side of Gordon Street in Judson Mills No. 2 Village, being known and designated as
Lot No. 1 of Block B as shown on a plat of Judson Mills No. 2 Village made by Dalton & Neves,
Engineers, in March 1939, which plat is recorded in the R. M. C. Office for Greenville County in
Plat Book K, at pages 1 and 2, and having, according to said plat, the following metes and bounds,
to-wit:

Beginning at the Southwest corner of the intersection of Gordon Street and Georgia
Avenue, and running thence S. 9-37 E. with Georgia Avenue 80.8 feet to an iron pipe; thence S.
71-09 W. 200.3 feet to an iron pipe in the east line of Lot No. 2; thence with the line of Lot
No. 2, N. 8-47 W. 81 feet to an iron pipe on the South side of Gordon Street; thence with Gordon
Street N. 71-13 E. 199 feet to the beginning corner.

recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 212 at page 12.

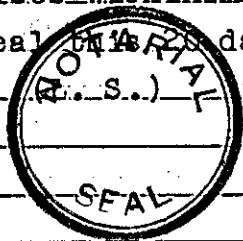
