

TITLE TO REAL ESTATE

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said M. E. Clarke, his heirs and assigns forever;

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, just outside the corporate limits of the City of Greenville, on the east side of Ladson Street and being known and designated as Lot No. 5, of Block B, of the property of O. P. Mills, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book C, at page 284, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Ladson Street at the joint corner of Lots Nos. 4 and 5, which point is 170 feet southeast from the southeast corner of the intersection of Ladson and Otis Streets, and running thence along the rear line of Lots Nos. 4, 3, and 2, N. 71-35-E. 173 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 5; thence S. 36-14-E. 40.8 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence along the joint line of said Lots 5 and 6, in a southwesterly direction 170 feet, more or less, to an iron pin at the joint corner of said lots on the east side of Ladson Street; thence with the east side of said Ladson Street, N. 35-32 W. 56.3 feet to the beginning corner.

This lot is shown on the Township Block Book at Sheet No. 219, Block 2, Lot 2, and the grantee is to pay taxes for the year 1945.
