All that certain piece, parcel or tract of land situate, lying and being on the northwest side of Lake Circle Road on Paris Mountain, in Paris Mountain, Township, Greenville County, South Carolina, being known as part of Lot No. 33, all of Lot No. 34 and a part of Lot No. 35 of Section B on plat of Paris Mountain Caesars Head Company made by R. E. Dalton, Jr., Eng., June, 1925, containing according to said plat, 4.88 acres, and having the following metes and bounds, to-wit:

BEGINNING at concrete monument on the northwest side of Lake Circle Road at joint front corner of Lots No. 34 and 35, also northeast corner of property of Broadus and Rebecca Bailey, and running thence with said Bailey line, S. 86-40 W. 421 feet to a concrete monument; thence N. 27-00 E. 335 feet to a concrete monument; thence N. 61-00 E. 600 feet to a concrete monument in line of property now or formerly of Mabel K. 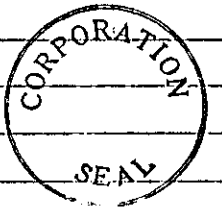
