All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the northwest side of Central Avenue, and being known and designated as Lot No. 11 of a subdivision known as "Dixie Heights", as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book H, at page 46, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of Central Avenue at the corner of Lot No. 10, and running thence along the line of that lot, N. 46-48 W. 150 feet to an iron pin; thence N. 45-12 E. 50 feet to an iron pin at the rear corner of Lot No. 12; thence along the line of that lot, S. 46-48 E. 150 feet to an iron pin on Central Avenue; thence along the line of said Central Avenue, S. 45-12 W. 50 feet to the beginning corner.
