on the Northern side of Harvley Street in the City of Greenville, being shown as Lot #6 on Plat of property of W. M. Jordan, et al, made by R. E. Dalton in March, 1921, recorded in Plat Book E, at Page 214 and described as follows:

BEGINNING at a stake on the Northern side of Harvley Street at corner of Lot #5 and running thence with line of said lot, N. 1-56 E. 105.8 feet to a stake; thence S. 87-05 E. 26.5 feet to a stake; thence S. 88-00 E. 23.5 feet to a stake; thence S. 1-56 W. 105.4 feet to a stake on Harvley Street; thence with the Northern side of Harvley Street, N. 88-04 W. 50 feet to the beginning corner. 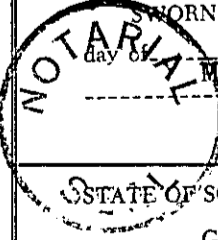
