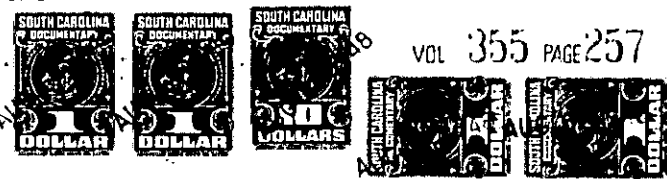

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Angus L. Vaughn, his Heirs and Assigns forever:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Western side of Mary Street, near the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 103 on Map #2 of Camilla Park, made by W. J. Riddle, Surveyor, December 1943, recorded in R.M.C. Office for Greenville County, S. C. in Plat Book "M", page 85, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Mary Street, corner of Lot #104, shown on said plat and running thence with the line of Lot 104, S. 67-50 W. 163 feet to an iron pin on rear line of Lot 100; thence along the rear line of Lot 100, N. 9-28 W. 80.7 feet to iron pin at joint rear corner of Lot 102 & 103; thence along the line of Lot 102 N. 65-35 E. 150 feet to an iron pin on the West side of Mary Street S. 21-45 E. 86 feet to the beginning corner.
