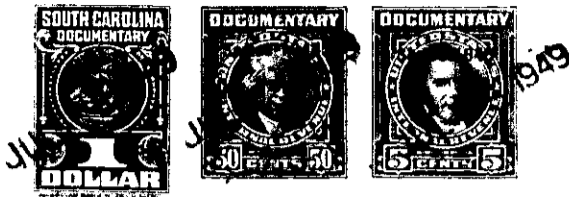

Southern, as Trustees of the O'Neal Church of God (xxx being located in the O'Neal Community, Greenville County, S.C., with International Headquarters at 2502 Montgomery Avenue, Cleveland, Tennessee,) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these

presents do grant, bargain, sell and release unto the said J. A. Reid, I. E. Duncan and A. L. Southern, as Trustees of the O'Neal Church of God, their successors in office and assigns forever,

all that piece, parcel or lot of land in O'Neal Township, Greenville

County, State of South Carolina, located about one-half mile East from O'Neal, lying on the Southeast side of Rutherford Road (the road leading from O'Neal to Berry's Mill), being bounded on the North by the said road and other lands of myself, on the East by lands of Jordan, on the South and West by other lands of myself, and being a part of the same tract of land that was conveyed to me by deed recorded in the office of the R.M.C. for Greenville County in Deed Book 225 at page 220, and having the following courses and distances, to-wit:
