

Dalton and Neves, Surveyors, dated November, 1941, and recorded in the office of Register of Mesne Conveyance in Greenville County, South Carolina, in Plat Book K, at Pages 106 and 107.

3. That certain strip or lot of land 20 feet in width extending Northeastwardly from Fourth Street to Brushy Creek, a distance of about 212 feet and being the area shown between Lots 10 and 11 as shown on said plat of Section 6 of Judson Mills Village, upon which lot is located a pump house.

4. Those two certain lots on the Eastern side of E Street bounded on the East by Brushy Creek and being particularly shown as Lots Nos. 19 and 20 on said plat of Section 6 of Judson Mills Village.

5. That certain tract or parcel of land containing 4.65 acres, more or less, bounded on the East by Valentine Street (formerly George's Road) for a distance of 813.5 feet, on the South by Maloy Street, on the West by Brushy Creek and on the North by property now or formerly of H. K. Townes.

6. That certain parcel or lot of land on the North side of Fifth Street particularly described as Lot No.108 upon the aforementioned plat of Section 6 of the lands of Judson Mills.

7. That certain parcel or tract of land containing 5.62 acres, more or less, lying South of Fifth Street and on both sides of Maloy Street and described by courses and distances as follows: Beginning at a point in the center of the bridge on Maloy Street crossing Brushy Creek, thence S 72-10 E 80.4 feet, thence S 56-27 W 554.3 feet, thence N 54-06 W 225.8 feet, thence S 51-08 W 192.5 feet to a point on the Northern side of Seventh Street, thence N 1-42 W 109.2 feet, thence S 88-10 W 140.4 feet and N 1-42 W 153.8 feet to a point on the Northern side of Sixth Street, thence N 88-20 E 210 feet, thence N 1-40 W 172.4 feet to a point on the Northern side of Fifth Street, thence with the Northern side of Fifth Street N 89-25 E 579.4 feet to Brushy Creek, thence down Brushy Creek S 1-08 W 174 feet to the beginning corner.

8. All that certain lot or parcel of land being triangular in shape, bounded by Honour Street, Neubert Avenue, and Ninth Street, and particularly shown as Lot No.12 upon a plat of Section 5 of Judson Mills Village made by Dalton and Neves, Surveyors, dated February, 1940, and recorded in said office in Plat Book K, at pages 33 and 34.

9. All that lot on the East side of Hawkins Avenue and extending from Ninth Street to Tenth Street, and particularly shown as Lot No.21 upon the said plat of Section 5 of Judson Mills Village, upon which lot is located the Laundry.
