to the grantor(s) in hand paid at and before the scaling of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. Wesley Clemens and Gladys Quay Clemens, their heirs and assigns, All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot #230, Pleasant Valley Subdivision, as per plat thereof recorded in Plat Book "P", at Page 92, in the R. M. C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Potomac Avenue, said pin being 360 feet from the Southeast corner of the intersection of Potomac Avenue with Panama Avenue, and running thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of lots #229, #230, #274, and #273; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of lots #230, #231, #273, and #272; thence N. 0-08 J. 160 feet to an iron pin on the South side of Potomac Avenue; thence along Potomac Avenue S. 89-52 J. 60 feet to an iron pin, the point of beginning.
