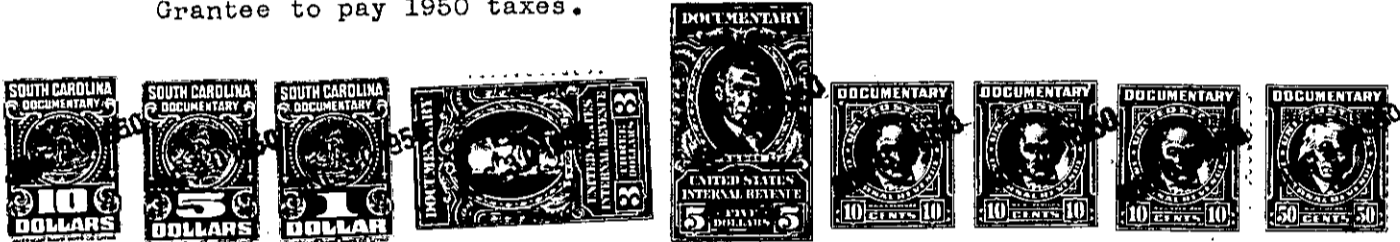
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Benjamin Owsley Merritt, Jr., his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southwest side of South Estate Drive, in Gantt Township, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 23, on plat of Crestwood, Inc., made by J.C. Hill Surveyor, February 28, 1949, said plat being recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 189, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of South Estate Drive, at joint front corner of Lots 21 and 23, and running thence with the line of Lot 21, S 28-00 W 185.7 feet to an iron pin; thence N 83-05 W 85 feet to an iron pin; thence along the line of Lot 25, N 31-05 E 218.6 feet to an iron pin on the Southwest side of South Estate Drive; thence with the Southwest side of South Estate Drive, S 61-00 E 65 feet to the beginning corner.

This is the same property conveyed to the grantor by deed of Crestwood, Inc., dated July 31, 1950, and recorded in the R. M. C. Office for Greenville County in Deed Book 415, at page 310.
