ment dated August 24, 1950
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said MELBA J. HENLEY, TRUSTEE for
MELBA RAY HENLEY Under That Trust Agreement dated August 24, 1950, her
successors-in-office and assigns,

all that piece, parcel or lot of land in Township,
County, State of South Carolina

TRACT I.

An undivided one-fourth (1/4) interest in that piece, parcel or lot
of land in Greenville Township, Greenville County, State of South Carolina, on the
East side of Main Street in Ward 2 of the City of Greenville as follows:

BEGINNING at a stake on Main Street and running thence 213 feet on
a line perpendicular to Main Street to a stake corner; thence 53 feet on a line
parallel with Main Street to a stake corner; thence 213 feet on a line perpen-
dicular to said street to a stake corner; thence 53 feet to the beginning corner.
This is a portion of the property deeded to me by Anna Bryan Wallace, et al by
deed dated May 20, 1943 and recorded in the R. M. C. Office for Greenville County
in Deed Book 254 at Page 157.

TRACT II.

An undivided one-fourth (1/4) interest in that piece, parcel or lot
of land in Greenville Township, Greenville County, State of South Carolina, on the
East side of Main Street in Ward 2 of the City of Greenville as follows:

BEGINNING on the East side of Main Street, at corner of lot formerly
owned by W. T. Bull (now Bryan's) and running thence with Bull's line S. 73 E.
3.15 chains to a stake; thence S. 19 W. 27 3/4 feet to a stake; thence N. 73 W.
3.15 chains to Main Street; thence with Main Street N. 19 E. 27 feet to the
beginning corner. This is a portion of the property deeded to me by Anna Bryan
Wallace, et al by deed dated May 20, 1943 and recorded in the R. M. C. Office for
Greenville County in Deed Book 254 at Page 157.
