M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

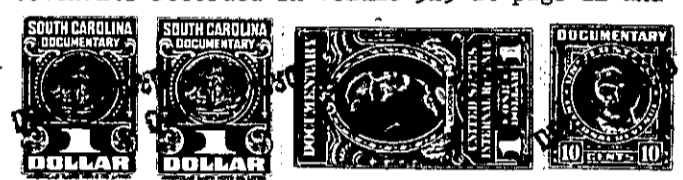
BEGINNING at an iron pin on the southern side of Brookside Circle at joint front corner of Lot Nos. 110 and 111 and running thence with the joint line of said lots S 37-34 E. 182.5 feet to an iron pin, joint rear corner of Lot Nos. 103, 104, 110 and 111; thence with the rear line of Lot No. 103, N 52-26 E. 75 feet to an iron pin, joint rear corner of Lot Nos. 102, 103, 111 and 112; thence with the joint line of Lot Nos. 111 and 112, N 37-34 W. 182.5 feet to an iron pin on the southern side of Brookside Circle; thence with Brookside Circle, S 52-26 W 75 feet to the point of beginning.
