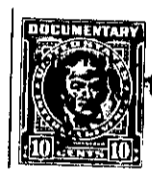

Bolt, Trustee for Marguerite Weaver and Virginia Weaver,

All that certain piece, parcel or tract of land situate, lying and being in Butler Township, Greenville County, containing 1.09 acres more or less according to plat made by J. C. Hill, Surveyor (said plat not recorded), and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the banks of the Roper Mountain Road and running along the Watson property S. 43-15 E. 155.9 feet to an iron pin; thence N. 51-30 E. 505.1 feet to an iron pin; thence N. 37 W. 39.2 feet to an iron pin on the Roper Mountain Road; thence along said Roper Mountain Road S. 63-50 W. 532.4 feet to an iron pin the beginning corner, and being a portion of the property conveyed to the grantor herein by J. S. Watson by deed dated the 11th day of November, 1947 and recorded in the R. M. C. Office for Greenville County in deed volume 326 at page 379.
