to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Karl E. Nuessner, his heirs and assigns forever:

All that lot of land in Chick Springs Township, Greenville County, State of South Carolina, near Paris Station being known and designated as lot 19, according to the plat of Super Highway Home Sites, made by Dalton & Neves, May 1946, as recorded in Plat Book P at Page 53, subject to building and other restrictions as set forth in an instrument recorded in Deed Book 291 at Page 369 and 370. Said records are in the office of Register Mesne Conveyance for Greenville County. Said lot has the following metes and bounds, to-wit:
