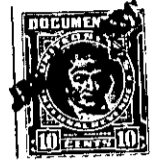


Know All Men by These Presents:

B. Bates property, as shown on plat recorded in Plat Book F at page 32, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Bishop Street at the corner of Lot 39 and running thence along the joint line South 48-30 West 142.5 ft. to an iron pin; thence South 55-40 East 50 ft. to an iron pin at the rear corner of Lot 43; thence along the joint line North 48-30 East 142.5 ft. to an iron pin on Bishop Street; thence along Bishop Street North 55-40 West 50 ft. to the beginning corner.
