Know All Men by These Presents:

That I, George W. Smith, Jr. in the State aforesaid, in consideration of the sum of --Five Hundred Fifty and no/100-\$550.00----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. M. Meadors, his heirs and assigns, forever:

All my one-half interest in and to that certain lot of land situate, lying and being in the County of Greenville, State of South Carolina, near the corporate limits of the City of Greenville, being known and designated as Lot #4 as shown on a plat of property of Charlie Rabb, dated March 6, 1922, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the Northeastern side of a certain alley shown on said plat, which point of beginning is 162 feet from the Southeastern side of Rutherford Street, and is the corner common to Lots 3 and 4 as shown on said plat, and running thence S. 64-30 E. along the line of said alley 50 feet to an iron pin at the corner of property of Watson; thence N. 33-30 E. 100 feet to an iron pin; thence N. 63-45 W. 50 feet to an iron pin at the corner of Lot #3; thence S. 33-30 W. along the dividing line between Lots 3 and 4, 100 feet more or less to the beginning corner.

The above is one of the lots conveyed to the grantor and grantee by W. R. Shives by his deed dated March 20, 1950, and recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 405, Page 493. However, said conveyance should have designated the grantor herein as George W. Smith, Jr.
