Know All Men by These Presents:

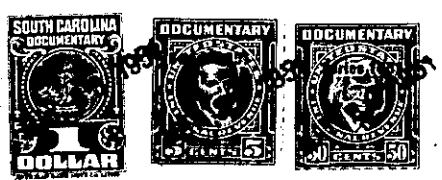
That **We, A.A. Wilson and Hattie A. Wilson** in the State aforesaid,

All those two certain lots of land in Chick Springs Township, Greenville County, State of South Carolina, known and designated as Lots Nos. 17 and 18 of block C of Buena Vista according to Plat recorded in Plat Book W at Pages 11 and 29, and when described together have the following metes and bounds, to-wit:
