All that piece, parcel, or lot of land in the State and County aforesaid, in the city of Greenville, being designated as Lot No. 124, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern Side of Brookside Circle at joint front corner of lot Nos. 123 and 124 and running thence with the joint line of said lots S. 37-34 E. 129.1 feet to an iron pin; thence with rear line of Lot No. 90 N. 52-26 E. 75 feet to an iron pin joint rear corner of Lot Nos. 124 and 125; thence with joint line of said lots N. 37-34 W. 113.3 feet to an iron pin on Brookside Circle; thence with said street S. 64-34 W. 76.9 feet to the point of beginning and being Lot No. 124.
