the receipt whereof is hereby acknowledged, does hereby grant unto said DUKE POWER COMPANY, its  
successors and assigns, the right, privilege, and easement to go in and upon that certain tract or lot of land  
situated in said County and State, ~~bounded by lands of~~ near Fountain Inn, and bounded  
by lands of J. R. Vaughn, Irene M. Vaughn and J. C. Vaughn and consist-  
ing of 1.377 acres as shown on a plat thereof recorded in the R. M. C.  
Office for Greenville County in Plat Book Z, at page 93,

and to construct, maintain and operate in, upon and through said premises, in a proper manner, with poles,  
wires and other necessary apparatus and appliances, a line for transmitting power by electricity, and for  
telephone purposes, together with the right at all times to enter said premises for the purpose of in-  
specting said line and making necessary repairs and alterations thereon, together with right at all times  
to cut away and keep clear of said line all trees and other obstructions that may, in any way, endanger  
the proper maintenance and operation of the same; also including the right to relocate said line over said  
premises to conform to any future highway relocation, widening or improvement.  
The exact location of said line shall be subject to the prior approval  
of Fairview Mills.
