Know All Men by These Presents:

That I, Walter W. Goldsmith
in consideration of the sum of FORTY NINE AND 50/100

in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marie P. Burns

ALL THAT piece, parcel or lot of land outside the City of Greenville in Greenville County near the intersection of White Horse Road and U.S. Highway #29 in a subdivision known as Rolando Hills, according to plat made by Piedmont Engineering Co. July, 1950, said plat recorded in RMC Office for Greenville County in Book "AA" at page 71, being lot #17 of Block C on Morrell Drive and being more particularly described as follows:

BEGINNING at an iron pin on W/s of Morrell Drive, joint corners of lots #17 and #18 and running thence N. 31-15 E. 60' along said Morrell Drive to an iron pin; thence N. 58-55 W. 130.7' to an iron pin; thence S. 37-31 W. 90' to an iron pin; thence S. 70-32 E. 143.2' to an iron pin on Morrell Drive, point of beginning.

RESTRICTIONS:

1. Said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent.
2. No residence shall be erected at a cost less than \$3000, nor nearer than 25' to the front line; nor shall any residence be erected on any lot unless said lot have 50' frontage or more.
3. No outside toilets are permitted and sewage must be disposed of by approved septic tanks.

Grantee herein to pay taxes for the year 1951.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
