

Know All Men by These Presents:

That I, Robert J. Edwards in the State aforesaid,  
in consideration of the sum of Three Thousand and No/100- - - - - (3000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said George L. Campbell, his Heirs and Assigns forever,

All those two certain pieces, parcels or lots of land in Chick Spring Township, Greenville County, State of South Carolina, situate on the Southeastern side of Super-Highway No. 29, being shown as Lots Nos. 210 and 211 on Plat of the Property of Robert J. Edwards, made by Dalton & Neves in March 1951, and having according to said Plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southeastern side of Super-Highway No. 29 at the joint corner of Lots Nos. 211 and 212, and running thence with the line of Lot No. 212 S. 47 E. 325 feet to an iron pin; thence S. 43 W. 200 feet to an iron pin at the rear corner of Lot No. 209; thence with the line of said lot, N. 47 W. 325 feet to an iron pin on right-of-way of Super-Highway No. 29; thence with the Southeastern side of Super-Highway No. 29, N. 43 E. 200 feet to the point of beginning.

Grantee to pay 1951 taxes.

It is distinctly understood and agreed that the above lots are conveyed subject to the following restrictions, which are expressly made a part of the consideration for this conveyance, and are for the mutual benefit of the Grantor, Grantees and other persons owning lots shown on the above referred to Plat:

- (1) Said lots shall be used exclusively for residential purposes only.
- (2) No dwelling shall be erected on said lots nearer than 100 feet to the front line of said lot.
- (3) No dwelling shall be erected on either of said lots to cost less than \$10,000, but this shall not apply to servant's quarters to be erected on rear portion of said lots.
- (4) Said lots shall not be subdivided so as to construct more than one dwelling on the front of each lot to have a frontage of 100 feet each.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

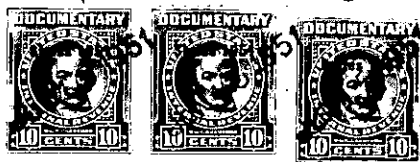
