Know All Men by These Presents:

That We, Walter W. Goldsmith and Elizabeth G. McCall in consideration of the sum of FORTY NINE AND 50/100 in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore .

ALL THAT piece, parcel or lot of land in Gantt Township, Greenville County on W/s of Evelyn Drive being lot #11 at intersection of said drive and Spears Drive, according to plat of White Horse Addition made by J.C. Hill, May 15, 1951, said plat recorded in RMC Office for Greenville County in Book "W", page 187, said lot being more particularly described as follows: BEGINNING at an iron pin, joint front corners of lots #11 and #12; thence S. 30-45 E. 67' along Evelyn Drive to an iron pin, intersection of Spears Drive; thence S. 77 E. 200' along Evelyn Drive to an iron pin; thence N. 30-45 E. 69.4' to an iron pin; thence N. 77-40 E. 200' to an iron pin on Evelyn Drive, point of beginning.

This deed is made subject to any easements or rights of way conveyed to Duke Power Company

Restrictions:

- 1. Said lands shall not be sold, rented or otherwise disposed of to any person of African descent.
2. No residence is to cost less than \$4,000; no residence shall be erected on said lot nearer than 50' to the front line; and no residence shall be built on any lot unless said lot has 50' or more frontage.
3. No outside toilets are permitted and sewage is to be disposed of by approved septic tanks.

Grantee herein to pay taxes for the year 1951.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and fore or defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
