Know All Men by These Presents:

That I, Mary McDougale Burns in the State aforesaid, in consideration of the sum of Five and No/100(\$5.00)----- DOLLARS, and division of real estate, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MILDRED MCDUGGLE THORESON, her heirs and assigns, all my right, title and interest in and to the following property:

All that certain piece, parcel or tract of land containing 32.97 acres, more or less, situate, lying and being in Oaklawn Township, County of Greenville, State of South Carolina, and having according to a plat and survey of the lands of J.W.M. McDougale, prepared by E.E. Gary, Surveyor, March 20, 1948, the following metes and bounds, to-wit:

BEGINNING at a point in the center of a County road known as Holly Drive and running thence along the center of said road, N 6-00 E 4.36 chs to a point; thence N 75-30 W 2.38 chs to an iron pin; thence N 7-30 W 4.55 chs to an iron pin; thence N 71-30 E 5.31 chs to a point in the center of said Holly Drive; thence with the center of said road N 11-00 E 2.85 chs to a point in said road; thence S 85-50 E 18.13 chs to an iron pin; thence crossing a branch S 60-30 E 1.65 chs to an iron pin; thence S 5-00 W 15.30 chs to a stone; thence recrossing said branch N 79-00 W 20.12 chs to point of beginning.

Being part of the lands of which the late J.W.M. McDougale was seized at his death on February 8, 1922(see Apartment 172, File 7, records of Probate Court). The Grantor and Grantee are the sole heirs at law and distributees of their mother, Essie C. McDougale who died intestate March 6, 1941, as will appear by reference to Apartment 534, File 9, records of said Probate Court.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
