That I, E. R. Griffin, in consideration of the sum of Fourteen Thousand and No/100 (\$14,000.00) - - - - - DOLLARS,

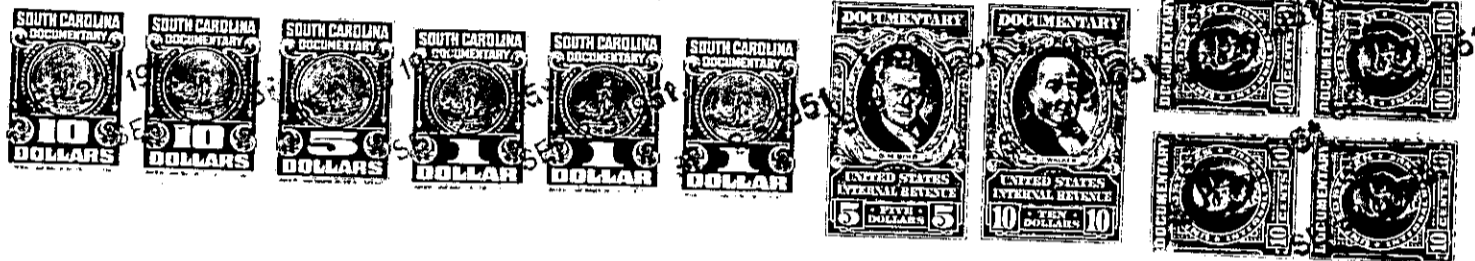

All that lot of land with the improvements thereon situate on the Northwest side of Bradley Boulevard, in the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 103 on plat of University Park, made by Dalton & Hayes, Engineers, November 1946, recorded in the R. M. S. Office for Greenville County, S. C., in Plat Book "P", at page 127, and having, according to said plat the following metes and bounds, to-wit:
