NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Walter S. Griffin an undivided one-half (1/2) interest, unto
the said H. B. McKoy an undivided one-fourth (1/4) interest, unto the
said Sam R. Zimmerman an undivided one-eighth interest, and unto the said
Sam . Zimmerman, Jr., an undivided one-eighth (1/8) interest in and to
the following described real estate:

"All that piece, parcel or lot of land in Greenville County, South
Carolina, on the North side of the Laurens Road, and having, according
to plat made by Piedmont Engineering Service, June 1, 1951, the following
metes and bounds, to wit:

BEGINNING at an Iron pin on the North side of the Laurens Road joint
corner of Parie Lee Green and J. A. Southern and running thence along
the North side of the Laurens Road, N. 53-04 W. 961 feet to an iron pin;
