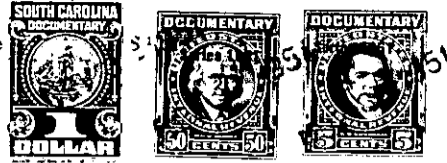

Know All Men by These Presents:

That Larthun Durham in the State aforesaid,  
in consideration of the sum of Two Hundred and No/100 (\$200.00) DOLLARS.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Fredrick D. Thomason, his heirs and assigns, all that certain piece, parcel or tract of land in the County of Greenville, State of South Carolina, in Butler Township, containing 4.05 acres and being a portion of the J. A. Bull property, plat of which is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book L, page 103 and having, according to a more recent plat made by W. J. Riddle, Surveyor, October 23, 1951, the following metes and bounds, to wit:

BEGINNING at an iron pin near the center of a County Road and adjoining property now or formerly owned by I. A. Brockman and running thence N. 0-30 E. 448.6 feet to an iron pin; thence N. 58-00 E. 402.5 feet to an iron pin; thence S. 22-08 E. 300 feet to an iron pin near the center of a road and adjoining the Raymond Durham property; thence through and near the center of the said road S. 32-45 W. 185 feet to an iron pin in the center of a county road; thence through and near the center of the said county road S. 60-00 W. 182 feet to a point; thence continuing through and near the center of the said county road S. 55-30 W. 242 feet to an iron pin, the point of beginning.

This is a part of a tract of land containing 97.65 acres, property of Larthun Durham and conveyed to him by J. A. Bull, by deed dated September 18, 1941, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deeds Volume 237, page 303.

This deed is in correction of a deed between the same parties, dated September 23, 1950 and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deeds Volume 419, page 397 and adds to the acreage contained therein an additional 2.05 acres.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
