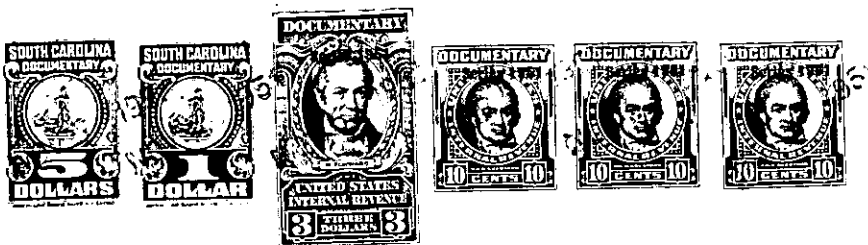
Know All Men by These Presents:

All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 28 on plat of property of F. B. Massingale made by C. Coke Smith, May 15, 1947, and having the following metes and bounds according to said plat:

BEGINNING at a stake on the south side of Arch Street Extension at corner of Lot No. 29, and running thence with line of lot No. 29 in a southeasterly direction 226 feet to a stake; thence S. 60-25 W. 60 feet to stake at corner of Lot No. 27; thence in a northwesterly direction with line of Lot No. 27, 226.7 feet to stake on Arch Street Extension; and thence with Arch Street Extension N. 60-25 E. 60 feet to the beginning corner.
