That I, Grace K. Styles in the State aforesaid, in consideration of the sum of Two Thousand (\$2,000.00)-----DOLLARS,

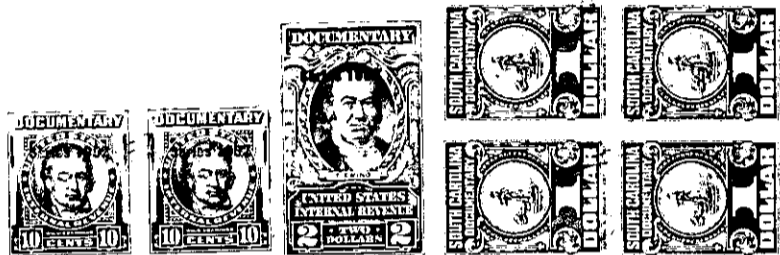

All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of Longview Terrace, in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 47 on Plat of Forest Heights, made by Dalton & Neves, Engineers, June, 1946, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "P", page 71, and having according to said plat, the following metes and bounds, to-wit:
