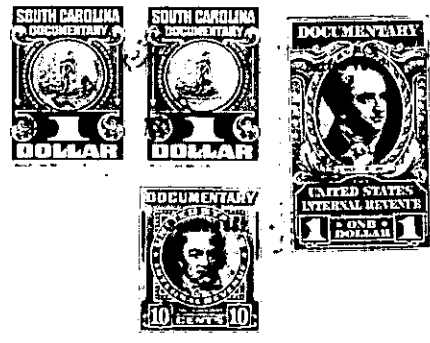

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 117 of a subdivision known as Section "A", of Englewood Estates, as shown by a Plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville, South Carolina, in Plat Book Y at Page 140, and having the following metes and bounds to-wit:

BEGINNING at an iron pin joint corners of Lots No. 117 and 119 and running thence along the line of said Lot No. 119, N. 87-30 W. 234.04 feet to iron pin at rear line of Lot No. 116; thence along the rear line of said Lot No. 116, N. 13-15 W. 104.7 feet to iron pin on Englewood Frive; thence with the line of Englewood Drive, S. 87-30 E. 239.7 feet to iron pin at curve; thence at an angle in a northeasterly direction 34.6 feet to iron pin; thence with the line of Overbook Drive S. 2-30 W. 75 feet to point of beginning.

THIS deed is made subject to the following restrictions:

1. No house is to be reected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. Notemorary house is to be erected on said lot.
