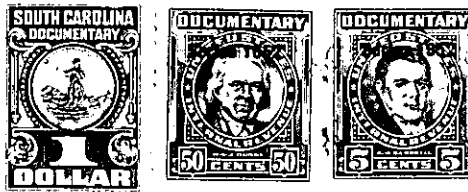

And they, the grantor(s) do es hereby bind himself, his heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Grantee(s) hereinabove named, and his heirs and assigns against him and his heirs and assigns, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
