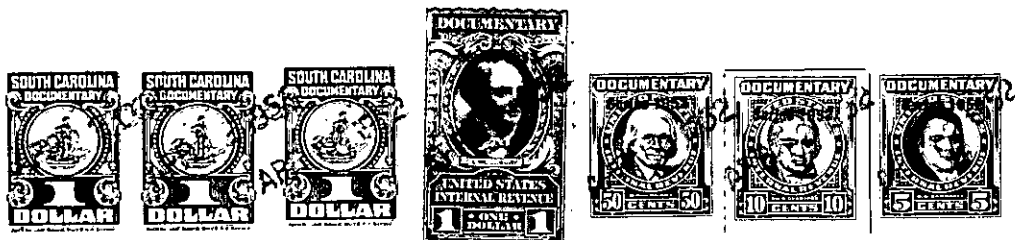

ALL that lot of land in Greenville County, State of South Carolina on the Southern side of Prancer Avenue in the City of Greenville, being shown as Lot No. 309 on a plat of property of Pleasant Valley, recorded in the RMC Office for Greenville County in Plat Book "P", at page 92 and described as follows :
