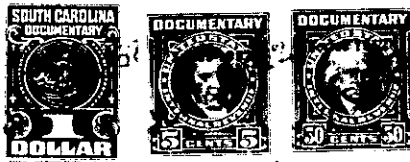

That I, J. L. Johnson, Individually and as Trustee for Nannie E. Smith in the State aforesaid, in consideration of the sum of FOUR HUNDRED and No/100 (\$400.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Henry C. Brown, his Heirs and Assigns forever, all that certain piece, parcel or lot of land in Cleveland Township, County of Greenville, State of South Carolina, and being known and designated as lot No. 9 according to a plat of the subdivision of the property of J. L. Johnson made by J. C. Hill L.S., June 7, 1952, said lot containing 4 acres, more or less, and being described according to said plat, as having the following metes and bounds, to-wit:

BEGINNING at a pin in the New Gap Road, joint front corner of lot Nos. 9 and 10, and running thence with line of lot No. 10, S. 70-45 E., 596 feet to a pin, joint rear corner of lots Nos. 9 and 10; thence running with the rear line of lot No. 9, S. 49-15 E., 300 feet to a pin, joint rear corner of lot No. 9; thence running with line of lot No. 8, S. 40-4 E., 434 feet to a pin in New Gap Road; thence continuing in a Southeasterly direction, 21 feet, to a pin in the center of New Gap Road at the corner of the road and the line of lot No. 9 with the center of New Gap Road, S. 46-15 E., 128 feet to a pin, joint front corner of lots Nos. 9 and 10, which is the old line corner; and the tract is formerly owned by J. L. Johnson.
