Paul L. Payne,
That We, Lauda Belle Payne Finley, and Marie Payne Riddle in the State aforesaid,
in consideration of the sum of One ----- DOLLARS,

and division of property,
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Grantee, namely: William Ralph Payne, his heirs and assigns forever:

All our right, title and interest in and to all that certain tract of land situate in Grove Township, Greenville County, State of South Carolina, containing 19.22 acres, more or less, according to plat of C. O. Riddle, Surveyor, made December, 1952, of property of the G. W. L. Payne Estate, and designated as Tract No. 1 on said plat, and having the following metes and bounds, to wit:

BEGINNING at a point in a county road and running thence N. 17-50 W. 20.3 feet to a point in edge of said road, and thence continuing on said course 921 feet to an iron pin in line of McKensie land; thence with line of McKensie and Riddle lines N. 40 - 10 E. 423. 2 feet to stone and iron pin corner; thence with line of Riddle land S. 45-45 E. 1209 feet to an iron pin; thence S. 12-15 E. 400.7 feet to edge of said road, and thence continuing on said course 35.7 feet to a point in said road; thence running in said road as follows: N. 82-37 W. 449.5 feet to bend, thence N. 88-46 W. 287.8 feet to bend, thence S. 81-55 W. 210.2 feet to the beginning corner.
