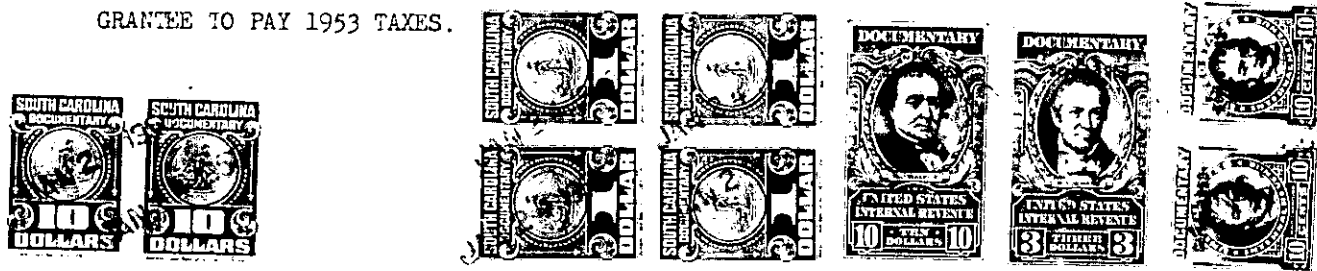
Louis B. Bryant, his heirs and assigns forever:

All those pieces, parcels or lots of land, in the above County and State, located on the South side of Buncombe Road, being designated as Lots Nos. 4, 5, 6, 7 and 8 on a plat of property of Marsmen, Inc., made by Dalton & Neves, May, 1944, recorded in the WC Office for Greenville County in Plat Book "O", page 7, and having according to said plat the following metes and bounds, to-wit:

BEGINNING on the South side of Buncombe Road at joint corners of Lots 8 and 9, and running thence with line of Lot 8 S 27-24 W 200 feet to an iron pin in line of Lot No. 3; thence with line of Lot No. 3 S 62-53 E 125 feet to an iron pin in line of Lot No. 3 and corner of Lot No. 4; thence with line of Lot No. 4 N 27-24 E 200 feet to an iron pin on the South side of Buncombe Road; thence with Buncombe Road N 62-53 W 125 feet to an iron pin, the beginning corner.
