in consideration of the sum of Nine Hundred And No/100 (\$900.00) - - - DOLLARS,

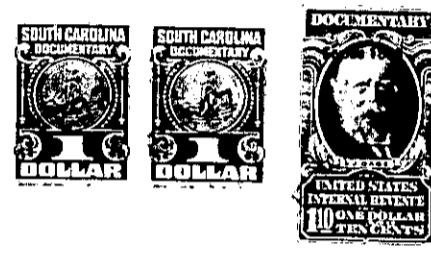
